

THE T-MOBILE UPGRADE YOUR HOME EXPERIENCES SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The T-Mobile Upgrade Your Home Experiences Sweepstakes (“Sweepstakes”) is sponsored by T-Mobile USA, Inc. (“Sponsor”), 12920 SE 38th Street, Bellevue, WA 98006, and is administered by Prize Logic, LLC (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

Day 5: December 22, 2020 prizes:

No more than five (5) Day 5 Entry Period 1 Prizes will be awarded. The ARV of each Day 5 Entry Period 1 Prize is \$2,500.
3. **Day 5 Entry Period 2 Prizes (5):** Each Day 5 Entry Period 2 prize includes an a catered dinner at home for winner and up to seven (7) guests (winner will be contacted to make arrangements) and new dishware set for eight (8) (each a “Day 5 Entry Period 2 Prize”). No more than five (5) Day 5 Entry Period 2 Prizes will be awarded. The ARV of each Day 5 Entry Period 2 Prize is \$2,076.
4. **Day 5 Entry Period 3 Prizes (5):** Each Day 5 Entry Period 3 prize includes Made-In executive cookware set and digital code for a one (1) year of Yes Chef access (each a “Day 5 Entry Period 3 Prize”). No more than five (5) Day 5 Entry Period 3 Prizes will be awarded. The ARV of each Day 5 Entry Period 3 Prize is \$1,205.
5. **Day 5 Entry Period 4 Prizes (5):** Each Day 5 Entry Period 4 prize includes a \$500 food delivery card (each a Day 5 Entry Period 4 Prize”). No more than five (5) Day 5 Entry Period 4 Prizes will be awarded. The ARV of each Day 5 Entry Period 4 Prize is \$500.

C. Total ARV: The total ARV of all available prizes in this Sweepstakes is 66,690.

D. Odds of Winning: The odds of winning an Entry Period prize depend on the total number of eligible entries received during each Entry Period. The odds of winning a grand prize depend on the total number of eligible entries received during each Day of the Sweepstakes.

The potential winners will be notified on Twitter or Instagram by a Direct Message from @TMobile (with instructions on how to claim his/her prize. The potential winners must respond to Twitter/Instagram Direct Message winner notification within twenty four (24) hours or they may, at the Sponsor's sole discretion, be disqualified.
